MEMBERSHIP TRANSFER SCHEME – RULE 23A

- 23A(i) The Club shall maintain a Membership Transfer List to include Ordinary and/or Life Members who have applied to relinquish their membership of the Club, and Ordinary Members who have applied to convert their membership to Silver Membership in accordance with Rule 14B. The Club shall also maintain a Waiting List in respect of non-members who have requested to be admitted as Ordinary Members (“the Candidate”) of the Club and have been proposed for membership to the Club. The Membership Transfer List and the Waiting List shall operate on a first come first served basis. The Membership Transfer List and Waiting List shall each comprise two (2) subsidiary lists, one (1) subsidiary list in respect of Singaporeans and the other, in respect of non-Singaporeans.
- 23A(ii) An Ordinary Member seeking to convert his or her membership to Silver Membership, and an Ordinary or Life Member seeking to transfer his or her membership (“The Transferor”) shall make a request in writing to the Club to be placed on the Membership Transfer List. Whether such an Ordinary or Life Member should be placed under the subsidiary list for Singaporeans or the subsidiary list for non-Singaporeans shall be determined by the citizenship of the said Ordinary Member or Life Member as at the time he or she was admitted to the Club, except for the provisions of Rule 23B.
- 23A(iii) An Ordinary Member shall not be placed on the Membership Transfer List unless his or her monthly subscriptions for the preceding twelve (12) months have been paid in full when they are due (in accordance with Rule 30).
- 23A(iv) An Ordinary Member seeking to access the Membership Transfer Scheme under this Rule shall continue to be liable for monthly subscriptions in respect of his or her Ordinary Membership until the membership has been transferred to the new member.
- 23A(v) If a member who has made a request under Sub-Rule 23A(ii) has his name subsequently placed on the Absent Members’ List or becomes in arrears of his monthly subscription under Rule 30, that member shall be removed from the Membership Transfer Scheme.
- 23A(vi) The Club shall be paid, as the Processing Fee, an amount equal to 33% of the prevailing Ordinary Membership Entrance Fee by way of deduction from the prevailing Ordinary Membership Entrance Fee received by the Club from the Candidate, being due to the Ordinary Member to relinquishing his membership.
- 23A(vii) On application by the Ordinary or Life Member to transfer his membership, or on application by the Ordinary Member seeking to convert his Ordinary Membership to Silver Membership under Rule 14B, the Club may place the membership of an Ordinary Member or Life Member on the Membership Transfer List where the following conditions are met:

- (a) the Club has notified the Ordinary or Life Member in writing of the Club's agreement to transfer the said Members' membership or elect the said member to Silver Membership; and
 - (b) the Vacancy so formed, once the member ceases to be a member or his membership is converted is for the purpose of satisfying the demand on the Waiting List.
- 23A(viii) The Transferor seeking to transfer his or her membership under Sub-Rule 23A(ii) may request the Club in writing that the membership be transferred to his or her child or grandchild, provided the child is at least twenty-five (25) years of age and is on the Waiting List.
- 23A(ix) When there is a request pursuant to Sub-Rule 23A(viii), the Club shall consider such request. Where, in exercise of the Club's discretion, a transfer of membership is sanctioned pursuant to this Sub-Rule 23A(ix),
- (a) the child or grandchild of the Transferor shall be resident in Singapore; and
 - (b) the child or grandchild of the Transferor shall pay the full prevailing Ordinary Membership Entrance Fee as prescribed under Rule 29.
 - (c) the Club shall at all times maintain the prevailing mix of Singaporean and Non-Singaporean Members except for the provision under Rule 23B.
- 23A(x) Upon notification by the Club that it has received the full prevailing Ordinary Membership Entrance Fee the Club shall proceed to transfer the Transferor's membership. The Transferor shall immediately cease to be a member on receipt by the Transferor of the full Entrance Fee for Ordinary Membership less the Processing Fee retained by the Club in accordance with Rule 23A(vi).
- 23A(xi) An Ordinary Member or Life Member electing to offer his membership for transfer under the Membership Transfer Scheme will receive payment as soon as the Club has received the full amount of the prevailing Ordinary Membership Entrance Fee from the incoming Ordinary Member (Candidate), less the Club's Processing Fee as provided for in Rule 23A(vi).
- 23B. When there is a request pursuant to Rule 23A(i) and 23A(ii), the Club shall consider such request. Where, in exercise of the Club's discretion, a transfer of membership is sanctioned, pursuant to this Sub-Rule, the Club shall at all times maintain the prevailing mix of Singapore and Non-Singapore Members with the exception that in the event that the Club has been unable to procure a non-Singaporean Candidate to acquire Ordinary Membership to the Club after twelve (12) months of the Ordinary or Life Membership held by a non-Singapore Ordinary or Life Member being on the Membership Transfer List, then the Committee may classify that Non-Singapore Ordinary or Life Membership as an "open category" Ordinary Membership and available for transfer to either a Singapore or Non-Singapore Candidate.
